

PRIVACY NOTICE PURSUANT TO EU REGULATION NO. 679/2016 (“GDPR”)

Dear Friend,

F.C. Internazionale Milano S.p.A. (hereinafter, **Inter**), with registered office in 20124 Milan, Viale della Liberazione no. 16/18, corporate capital of Euro 19,195,313.34, fiscal code and number of registration with the Companies’ Register of Milan 80066310154, in its quality of data controller, provides you with this Privacy Notice pursuant to sec. 13 of GDPR.

1. Data processed, purposed and legal basis

Inter processes the personal data (hereinafter, the **Data**) of the subjects involved in the processing (hereinafter, **Data subject**) and in particular of the fans with a disability that purchase tickets for the matches of the team “F.C. Internazionale”, season tickets for the entire season 2021/2022 and onwards, supporter cards (*tessere del tifoso*) or Inter Club cards (hereinafter, jointly, the **Services**). This document represents an addendum to the General Privacy Notice, with particular regard to the disclosure of sensitive data of the Data subject (i.e. those contained in the certificate of disability). This disclosure is required as a condition to have access to some advantages at the time of the purchase of the Services and to benefit from dedicated services during the sporting events at San Siro Stadium (Milan). The Data are provided directly by the Data subject or by his/her legal guardian, for the only purpose to grant supporters with disabilities with the access to the above-mentioned advantages and dedicated services.

Please note that, inside and in the surrounding areas of the San Siro Stadium in Milan, a video surveillance system is operating in compliance with the provisions of the Decree of the Ministry of the Interior of 6 June 2005. The aforementioned video surveillance system is aimed at managing the safety of the sports facility and the prevention and repression of crimes during the sporting events (for any further information, please refer to the relevant Privacy Notice posted at the San Siro Stadium). It should also be noted that, in application of the INTER’S CODE OF CONDUCT (hereinafter, the **Code**) and of the “System of Rating” established by the F.I.G.C.’s Protocol of 4 August 2017, any images acquired through the video surveillance system can also be used for the purpose of detecting conducts held by the fans in violation of the provisions of the Code. In particular, the verification of any conducts contrary to the values of sport and the public sense of decency, as well as discriminatory conducts of any kind or detrimental to the image of the team "F.C. Internazionale", may lead to the imposition of interdictory or inhibitory measures against the infringer.

2. Means of processing

Inter hereby informs you that for the above-mentioned purposes the Data shall be processed also by computer, telematic, paper and manual instruments, in compliance with the confidentiality and safety rules provided by the law.

3. Optional disclosure of Data

The provision of the Data is optional. Any refusal to provide the Data for the above-mentioned purpose shall lead to the impossibility to benefit from the advantages and dedicated services offered by Inter, with consequent application of General Terms and Conditions of Purchase. Also a subsequent possible opposition or revocation of the processing of Data for the above mentioned purposes shall result in the immediate blocking of the supply of the Services.
